AFFILIATE CLUB REGIONAL BOUNDARY DOCUMENT

AUCKLAND INDIAN SPORTS CLUB INC:

[The boundaries are defined in conjunction with NHISC and the Auckland Hockey Association Boundaries]

Northern (Southern) Boundary: from Waiwera Bridge, across the coast to Wirenui Road to Kaukapakapa and region above this boundary, to the northern tip of the North Island.

Central (Northern) Boundary: northern coastline of Auckland City, west to Selwood Road, from the harbour south through Lincoln Road, Swanson Road, Bethells Road and West Coast Road.

Central (Western) Boundary: from the harbour through Lincoln Road, Swanson Road, Bethells Road and West Coast Road.

Central (Southern) Boundary: Northern Boundary no further than Kerr's Road, Manuwera.

Note: The Auckland ISC designated region encompasses the region under the control of North Harbour ISC.

BAY OF PLENTY INDIAN SPORTS CLUB:

Boundaries: North border that of Pukekohe ISC, West border with Waikato ISC, South Taupo's District to Ohakune and east encompassing the Tauranga region to Katikati and south east Taupo to Wairoa inclusive.

CENTRAL DISTRICTS INDIAN SPORTS CLUB:

Northern boundary: up to Waikato ISC border ending at Awakino southeast to Ohakune.

Eastern boundary: from Wairoa (excludes Wairoa) along Hawkes Bay coastline, south to Rimutaka Hills.

West from Awakino south including the regions of Taranaki and Wanganui to the North to the border Taupo District and South to Otaki but excluding Otaki.

CHRISTCHURCH INDIAN SPORTS CLUB:

[The boundary is defined as per original affiliation]

Northern, Western Eastern and Southern Boundaries: all defined as the entire South Island of New Zealand.

NORTH HARBOUR INDIAN SPORTS CLUB:

[Boundaries are defined as those for the North Harbour Hockey Association]

Northern Boundary: up to Waiwera Bridge, across the coast to Wirenui Road to Kaukapakapa.

Southern Boundary: southern coastline of the North Shore, west to Selwood Road.

Western Boundary: from the harbour north through Lincoln Road, Swanson Road.

Bethells Road, and West Coast Road.

The defined area is inclusive.

Areas outside the defined boundaries (that is, the area north of Waiwera Bridge, across the coast to Wirenui Road to Kaukapakapa, and the area bordering the southern coastline of North Shore, west to Selwood Road), remain the judiciary of Auckland Indian Sports Club.

PUKEKOHE INDIAN SPORTS CLUB:

[Boundaries are defined as those for the Counties Hockey Association]

Northern Boundary: no further than Kerr's Road, Manuwera.

Southern Boundary: no further south-east than Ngatea via Mercer Village.

Western Boundaries being Port Waikato, Eastern Boundary to Tairua,

WAIKATO INDIAN SPORTS CLUB:

Boundary considered the Northern border: Port Waikato on the west to Tairua on the East excluding Tairua.

Western Boundary: coastline from Port Waikato and south to Awakino.

Southern Boundary: Awakino southeast to Okakune, Turangi across to Wairoa on the east but excludes Wairoa.

WELLINGTON INDIAN SPORTS CLUB:

The boundaries are defined in conjunction with the Central Districts ISC.

1. The lower part of the North Island that is, the region south of Otaki. This includes Otaki.
2. West across to the Rimutaka Hills.
